Kako ih koristiti

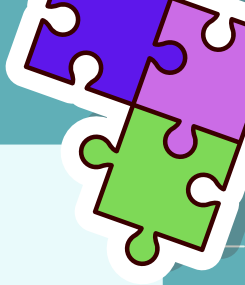
1. Odaberite jednu karticu s tiskanih kartica za refleksiju nakon završetka zadatka.
2. Pročitajte pitanje ili uputu na kartici.
3. Odvojite trenutak za razmišljanje prije nego što odgovorite.
4. Napišite ili izgovorite svoj odgovor.
5. Razgovarajte s prijateljem ili učiteljem ako želite.

O ovom predlošku

- Svaka kartica ima simbol i pitanje ili uputu za refleksiju.
- Boja i simbol pomažu vam da zapamtite vještinu koju koristite (npr. zelena i slagalica za planiranje)
- Pitanje vam pomaže da duboko razmislite o tome što ste učinili, kako ste se osjećali ili što biste mogli bolje učiniti.
- Neke kartice pitaju o tome kako ste planirali svoj rad, kako ste ostali usredotočeni ili koliko su dobro vaše strategije funkcionirale.

Savjeti za ponovnu upotrebu / nastavak

- Svaki put odaberite drugu karticu kako biste istražili nove kutove svog učenja.
- Zabilježite svoje odgovore u dnevnik kako biste vidjeli kako napredujete.
- Pokušajte stvoriti vlastite kartice s novim pitanjima.
- Koristite istu karticu s različitim predmetima ili projektima.



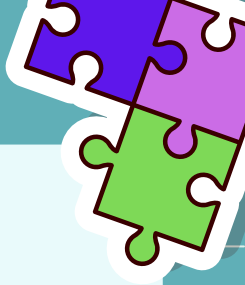
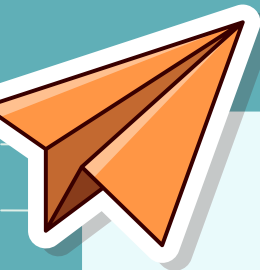
